**Public Service** — The section's primary pro bono project is fundraising and financial support for the Women's Advocacy Project, which operates family violence legal lines and general legal hotlines and provides other services for battered women and victims of family violence, including a pro se protective order program for Texas women who live in rural areas not served by county programs.

The section also encourages women to serve as speakers for State Bar and other CLE providers.

Member Services — The section sponsored the 17th annual "Women and the Law Institute" on March 25 in Dallas. The institute offered 6.25 hours of MCLE for a nominal fee, and included topics on gender bias studies, violence against women, family law and probate law, alternative dispute resolution, women in education, and sex discrimination and sexual harassment in employment.



The section also honored its past presidents and presented its annual Sarah T. Hughes Award to Justice Ann McClure of El Paso for influencing other women and advancing opportunities for women within the profession. The annual Ma'at Justice Award was presented to Iris Hefter Robinson of Houston for actively addressing the needs of and issues affecting women.

The section produced a brochure for use in membership recruitment, including efforts at the swearing-in event for new lawyers. It is reviewing the need for a membership directory.

Last year, the State Bar of Texas Lawyer Referral and Information Service made almost 40,000 referrals to panel members. LRIS helps clients in need of legal assistance find lawyers and in doing so helps those lawyers build their practices.
